This Amendment No. 2 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the "SEC") on October 3, 2019, as amended by Amendment No. 1 thereto filed by the Reporting Persons with the SEC on February 11, 2020 (the "Schedule 13G").

Except as set forth below, all Items of the Schedule 13G remain unchanged. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Schedule 13G.

# Item 4. Ownership.

# (a) and (b):

As of close of business on December 31, 2020, each of the Reporting Persons may have been deemed to have beneficial ownership of 1,447,666 shares of Common Stock, which consisted of (i) 833,333 shares of Common Stock issuable upon an exercise of a warrant held by Intracoastal ("Intracoastal Warrant 1"), (ii) 174,333 shares of Common Stock issuable upon an exercise of a second warrant held by Intracoastal ("Intracoastal Warrant 2") and (iii) 440,000 shares of Common Stock issuable upon an exercise of a third warrant held by Intracoastal Warrant 3"), and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 3.8% of the Common Stock, based on (1) 36,954,755 shares of Common Stock outstanding as of November 5, 2020 as reported by the Issuer, plus (2) 833,333 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 2 and (4) 440,000 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 2 and (4) 440,000 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 2.
